

## Los Compadres de Escuela Longfellow

## **Audit Report**

May 27, 2014

### Introduction

The Los Compadres de Escuela Longfellow (Los Compadres), a nonprofit public benefit corporation organized as a public and charitable purposes was established in 2007. According to their Articles of Incorporation, "The specific purpose of this organization is to support the students, staff and administration of Escuela Longfellow in fundraising efforts encouraging capital improvements and infrastructure development through fundraising endeavors targeting alumni and corporate sponsored activities outside the campus."

We reviewed the financial activities of the Los Compadres for the period August 1, 2012 through February 28, 2014 at the request of the principal.

From 8/1/2012 to 2/28/2014, the Los Compadres deposited \$191,483.01 and withdrew \$153,597.39. As of 2/28/2014, the checking and savings bank accounts of the Los Compadres had a balance of \$61,382.53 and 46,872.93 respectively and a fund balance of \$108,255.46. Of the total fund balance, \$66,975.31 is in restricted funds. (See Schedule I)

#### Audit Scope and Objectives

The scope of this audit included a review of all available documents related to the financial activities of the Los Compadres from August 1, 2012 through February 28, 2014 to determine the following:

- The adequacy and effectiveness of the internal control system.
- The proceeds from fundraising activities are properly accounted for.
- The expenditures are authorized and have adequate supporting documentation.

#### **Audit Findings Summary**

1. A district employee was paid a total of \$590.00 directly by the Los Compadres instead of through the district's payroll system.

# Conclusion

Based on the results of the review of available documents, we determined that the Los Compadres books were in order.
