SUBJECT: MET High School's Follow-up Audit Report

Our office conducted a follow-up audit of the Out-of-District Transcript Audit Report dated August 3, 2010 for the San Diego Metropolitan Regional Career and Technical High School (Met). The follow-up audit report contains information regarding the audit findings and recommendations.

Enclosed is a copy of the audit report and responses to the audit findings. The administrator responsible for Finding 1 did not take corrective actions at that time based on the guidance of General Counsel. An audit exception remains where a total of 64 of the 106 errors reported in the original audit report's findings were not corrected for 15 students who graduated from the MET or exited to another school during the school years 2009 through 2012.

The site administrator responsible for Findings 2 and 3 was responsive to our recommendations and corrective actions have been taken.

INTRODUCTION

This report contains the results of our follow-up audit of the Out-of-District Transcript Audit Report dated August 3, 2010 for the San Diego Metropolitan Regional Career and Technical High School (Met).

Follow-up of internal audit findings and recommendations is an integral part of good management and is the Director of Internal Audit's responsibility. Our office conducts a follow-up audit to ensure the proper resolution of the audit findings and recommendations, and the implementation of corrective actions.

AUDIT SCOPE AND OBJECTIVES

The audit included a review of the original audit report and additional testing/examination of current supporting documentation. The objectives of the follow-up audit were:

- To determine that initial audit findings were effectively resolved, and that corrective actions, as recommended in the original audit, were implemented.
- To determine that out-of-district grades and course numbers were reported correctly on the transcripts for current students.
- To determine that independent study agreements existed for current students.
- To ensure compliance with applicable Education Codes and district procedures.

SUMMARY OF AUDIT FINDINGS

- 1. 64 of the 106 errors reported in the original audit report's findings numbers 1 through 5 have not been corrected.
- 2. A sample of 114 current out-of-district courses was reviewed. 14 courses were found to have improper posting of grades or course numbers, and 34 courses had the Big Picture course numbers rather than the earned district course numbers.
- 3. 24 current students were credited with the course "SR High AVID" by the Met. The Met has not participated in the certification process to be recognized as an AVID School.

CONCLUSION

The initial audit findings were not effectively resolved and the corrective actions as recommended in the original audit were not entirely implemented. Noncompliance to applicable Education Codes and district procedures still exist. In the original audit report's findings numbers 1 through 5, 64 of the 106 errors found have not been corrected. The 64 errors not corrected represent out-of-district course grades that were originally entered incorrectly or represent out-of-district courses that were never earned by the student, yet entered for credit on the transcript. Of the 64 remaining errors, the area superintendent that was tasked with addressing the audit findings properly corrected 22 of the grades; however, the same courses with a higher grade were added as earned at the Met (one added as earned at another district site). Additionally, 3 of the 64 errors were not corrected and the same courses with a higher grade were added as earned at the Met. The added and re-entered courses did not previously exist on the transcript at the time of the original audit. These are intentional postings, not errors.

The follow-up audit results shows a lack of action to correct the previous errors that resulted in student transcripts presenting grades and GPA(s) more favorably than from reporting the actual grades earned out-of-district. These grades, shown as out-of-district, would mislead a reviewer's assessment since the grades were not earned out of district, but awarded by Met staff based on Met matrices and not awarded by the out-of-district schools. The giving of out-of-district course credit for courses not earned also misrepresents the students' transcripts.

In regards to current year testing, compliance was met for proper independent study agreements and supporting documentation for current students.

A total of 14 errors were found for entering incorrect out-of-district grades and course numbers to the students' transcripts, as well as the error of giving more unit credit for certain courses taken than actually earned. These errors affect the integrity of the transcripts.

We appreciate the cooperation extended by the staff and current administration during the examination.

AUDIT FINDINGS AND RECOMMENDATIONS

1. 64 of the 106 errors reported in the original audit report's findings numbers 1 through 5 have not been corrected.

The 64 errors not corrected represent out-of-district course grades that were originally entered incorrectly or represent out-of-district courses that were never earned by the student, yet entered for credit on the transcript. Of the 64 remaining errors, the area superintendent that was tasked with addressing the audit findings properly corrected 22 of the grades; however, the same courses with a higher grade were added as earned at the Met (one added as earned at another district site). Additionally 3 of the 64 errors were not corrected and the same courses with a higher grade were added as earned at the Met. The added and re-entered courses did not previously exist on the transcript at the time of the original audit.

For example, a student enrolled at Met in 2/2/2009, and the Met staff entered an out-of-district course on 2/2/2009 which was never taken. Met staff stated that the student performed the work through Independent Study; however, the course was entered on the first day of enrollment and shown as out of district; in accordance with district procedure and Education Code, the Met work cannot replace or elevate an out-of-district course. Based on the audit finding, the area superintendent that was tasked with addressing the audit findings removed the out-of-district course never taken, but added the same course as earned at Met in June 2009. At the time of the original audit, the 4/2010 transcript did not show this course as earned at the Met in June 2009.

Based on the follow-up audit, the following table displays the results of the current status of the previously reported findings and recommendations:

Recommendation

To comply with Education Codes and District Procedures, administration should correct all original audit findings. In accordance with district procedure and Education Code, staff should award grades as earned at the Met when course work is assigned and evaluated by Met staff. The courses and grades taken out-of-the district cannot be replaced by work through Independent Study and adding the same course as earned at the Met.

2. A sample of 114 current out-of-district courses was reviewed. 14 courses were found to have improper posting of grades or course numbers, and 34 courses had the Big Picture course numbers rather than the earned district course numbers.

114 out-of-district courses were examined for proper entry of grades on the transcript. 3 incorrect grade postings were noted (1 grade was entered lower, 2 grades were entered higher), and 2 grades (D) were not entered. Additionally, 6 courses had the incorrect course number entered on the transcript and 3 courses had the credit incorrectly entered for 2 semesters when only 1 semester credit was earned. In addition, 34 courses by mistake had the Big Picture (a course offering particular to the Met) course number rather than the district course number. Below is a summary of the findings:

Recommendation

The principal at Met has taken action to correct all errors found in Finding #2.

3. 24 current students were credited with the course "SR High AVID" by the Met. The Met has not participated in the certification process to be recognized as an AVID School.

This finding was not noted in the original audit. A review of student transcripts noted that Senior High AVID Course # 8060 is included as an elective course offering. The Met site is not included on the 2012-2013 San Diego Unified School District Certified AVID School list of schools eligible to offer AVID. The school transcripts show that 24 students have completed the Senior High AVID Course.

The Met, by not having certified as an AVID School, does not satisfy the requirements needed to offer the course.

Recommendation

In order to be recognized as an AVID School, Met must participate in the certification process. Until certified as an AVID School, the Met is not to include AVID as a course offering.
