A special meeting of the Board of Education of the San Diego Unified School District, County of San Diego, California, was held at the Eugene Brucker Education Center 4100 Normal Street, San Diego, California on June 3, 2010.

Call to Order

President Barrera called the meeting to order at 4:00 pm in the auditorium with all

members present.

Adopt Agenda Motion by member de Beck, seconded by member Evans to adopt the agenda was

approved unanimously.

Budget

Update on 2009-10 Budget and Development of 2010-11 District Budget (Attachment A3)

Joan Collins, Lauryn Gates, Katie Anderson, David Page, Marta Thiele, Deborah Ford, Marion Snell, and Mickey Davenport provided public testimony to the Board regarding update on the District budget.

Motion by member Evans, seconded by member Barrera to adjust the Board's calendar of meetings and schedule for agendizing as follows, item A4, elimination of classified vacant positions for a first reading on June 8; 2010-11 Budget adoption, first reading on June 22, and action on the 2010-11 Budget adoption on June 29, 2010, was approved unanimously.

Carolyn Vega, Jenny Trower, Michelle Sanchez, Reshal Torrevillas, Bill Freeman, Mike Martinez, Rachel Patterson, and Tim Farso provided public testimony to the Board regarding the proposal to rescind notices sent to probationary certificated employees.

Motion made by member Evans to rescind the notices sent to probationary certificated employees, died for lack of a second. Following discussion of the Board, member Jackson moved, member Evans seconded, rescind notices sent to probationary certificated employees and direct staff to cap number of new hires to no more than 120 temporary teachers; if staff determines more than 120 are needed, the recommendation shall come forward to the Board for consideration and approval, was approved with members Barrera, Evans and Jackson voting yes, member Nakamura voting no, and member de Beck abstains from the vote.
