Motion by member Jackson, seconded by member Evans to approve the job description for Area Superintendent (K-12) with minor modifications to emphasize support and accountability functions, and job description for Assistant Superintendent, Instructional Support Services was approved unanimously with member Nakamura absent.

Motion by member Evans, seconded by member Barrera to approve the remaining Superintendent recommendations at item A05 and that the area superintendents and their staff be located in their respective cluster areas failed, there was no action taken, in that members Evans and Barrera voted yes and member de Beck and Jackson voted no.
