Committee’s recommendations will go to the Board on June 14, 2011.</p> <p><b>MOTION:</b> Wright moved adoption of the Director of Internal Audit job description with the Committee’s edits, seconded by Barnett; approved unanimously with Barrera absent.</p> <p><b>ACTION:</b> Kate Allison will make all recommended changes presented by the committee. The Committee’s recommendations will go to the Board on June 14, 2011.</p>
