Chairperson's Report

- Approval of the Minutes: Minutes for the November 17, 2004, meeting were reviewed. Moved (McKinley) and approved.
- California Association for Compensatory Education (CACE): As a follow up from the previous month's discussion regarding the CACE conference, Mr. Page shared information on a book he obtained called *The African American Parent Guide to Public School Success* by Kevin L. Executive Board Report

District Reports/Training/Collaboration

- Consolidated Application Parts I and II: Art Palkowitz presented basic information concerning the Consolidated Application Parts I and II. To benefit the new members of the council, he defined the purpose of the Consolidated Application and how it is used to report categorical allocations provided to the district. One of the main elements of the Consolidated Application is Title I funding. Part of this information is on the Title I Ranking Report, which will be available via the district web-site. DAC Representatives received draft copies of the proposed Title I Ranking Report for 2005-06 school year funding.
- Coordinated Compliance Review (CCR) Update: Linda Dusharme reported that April 11-22 would be the dates the CCR team visits will take place. Principals were notified on December 15 of the schools that will be reviewed. Another update will be provided at the January meeting.

Site plans 2005-06: The SSC is responsible for evaluating school plans. The budget deadline for the allocation of funds for the 2005-06 school year is February 2. Revised site plans are due March 4 to the Planning and Accountability Department for board submission in May. An additional SSC training on site plans will be conducted at the Harold J. Ballard Center on January 26 and 27 from 4:00 p.m. to 6:00 p.m. Flyers will be sent out to individual schools with registration information.

- Ballard Parent Center: Maria Moore-Flagg, Supervising Administrative Assistant I, Ballard Parent Center, gave an update on free classes and services offered by the Ballard Center. She also had available a district fact sheet outlining information about the Ballard Center.
