 Title I Regular Title I Funds ARRA Funds SERP Repayment 	Informational: Debbie Foster, Financial Planning Manager	 SERP Update - Page was instrumental in obtaining a formal decision from the federal government directing the district to pay back unrestricted funds with first payment beginning in 2009-10 almost \$700,000 (exactly \$686,000) over a 3 year period back into Title I. ARRA Funds - Foster and Campbell gave a summary of how the ARRA Funds would be utilized. K2 teachers will pull a small group of students who are in need of assistance in English and Math for the entire year. Two programs identified for all 16 high schools; "Game On" an attendance incentive program for all 9th graders and a leadership program which identifies 10 males and 10 females students at each high school will receive support in a method like service "check and connect" i.e., tutoring, advisor, mentorship to assist them in order to be successful in school.
