Quick Announcements

Debra shared that the NABE Conference that will be held here in San Diego in February has added a free Parent Institute on Thursday, February 13, 2014. They are allowing our district to invite 10 participants. DELAC officers supported Debra's suggestion that the ten spaces be offered to our current DELAC officers and those who have served as officers recently (Yasmin Bozin, Olivia Ouchen, Luz Portillo, and Minerva Espejo). We need to have the RSVPs by December 1 from all invitees to the NABE Parent Institute as well the RSVPs from our current board members about whether they wish to attend one of the following big conferences: NABE, CABE, or ATDLE. Valentina reminded everyone that Supplemental Education Services tutoring applications are due.

Lallia shared that the Islamic Center received several phone calls that students who were absent from school due to recent Islamic holidays did not have these absences excused as "Religious Holidays". She did state that these calls came from families of students in other school districts, not San Diego Unified.

Nevada shared that Lallia had her first two school visits as ELAC Liaison (CPMA and Dana) and did a wonderful job.

Review of Written Petition to Change DELAC Bylaws

- 1. It was moved that, "The DELAC chairperson and the Executive Board Members will meet at least 2 weeks prior to each General meeting to determine the schedule, agenda, speakers, and activities for the General meetings" replace existing language about protocol and timelines for DELAC Executive Board meetings. Discussion followed. There was no second. Motion died.
- 2. It was moved that, "Members of ELAC and DELAC Executive Board members must present a written petition to amend, change or modify the bylaws at any time when needed" replace existing language about how often proposals to change bylaws can be considered. Discussion followed. There was no second. Motion died.
- 3. It was moved that the word, *"Informational"* be added to the description of the ELAC Liaison's duties in bullet number four: *"Assists sites in creating and maintaining their ELACs by giving motivational, encouraging, [and "informational"] presentations."* Discussion followed. There was no second. Motion died.
