Call to Order

Vice Chairperson Gabriela Contreras-Misirlioglu called the meeting to order at 6:30 p.m.

Reading of Minutes

Minutes of the December 6, 2012 General Meeting were read and approved.

Training Workshop: Robert's Rules of Order

Debra Dougherty, Program Manager, Office of Language Acquisition

Ms. Dougherty shared the history and purpose of Robert's Rules of Order. Robert's Rules outline a set of procedures that can be used to help committees conduct meetings in an orderly manner. She explained what a "motion" is and the steps in making motions. She also taught us three different ways of voting: voice vote, show of hands, and paper ballot. Table groups were guided through three "role-play" activities, which illustrated scenarios that might occur in ELAC meetings. During these role-play activities, we practiced making motions, discussing motions, following procedures, and voting.

Using Robert's Rules of Order is an option for school site ELACs, not a requirement. Each ELAC can determine the level of formality that is best for their group. A small group with close agreement within the group may operate very well without following strict rules. Decisions can be made through friendly discussion that leads to decision making by consensus. On the other hand, a group in which sharp differences of opinion exist, or many people wish to voice their opinions, might benefit from following procedural rules. The rules could include making motions, having structured discussions, and/or formal voting.

DELAC Homework and Announcements

OLA Resource Teacher Nevada Allen reminded DELAC representatives to share with their ELAC what they learned about Robert's Rules of Order and to decide as a group if these procedures might be helpful for their committee.

Participants were provided with sample communication tools, which have been used by actual ELACs to advise their principals and SSCs on the Single Plan for Student Achievement (SPSA) and the use of funding to support EL students.
