## **Presentation: Reclassification of English Learners**

Melody Margetta, English Learner Support Teacher, Marston Middle School

Ms. Margetta shared with DELAC her family story of the importance of education as the key to success and opportunity. She explained what reclassification is, the criteria for reclassification and the advantages of attaining RFEP status. She took members through the Reclassification Workshop she does with her students. Participants practiced completing an "Application for Reclassified English Proficient Status" using information from three

different sample Student History Profiles. She then shared a variety of suggestions of how parents can help their children improve their English proficiency. She ending by challenging parents to formulate at least one idea that they can put into place immediately to help improve their child's academic achievement.

## **Presentation: Zangle ParentConnect & StudentConnection**

Anthony Pham, English Learner Support Teacher, Montgomery Middle School and SCPA

Mr. Pham showed DELAC members the Zangle StudentConnection program. He explained that it is generally used in secondary schools and is a wonderful tool for parents to keep track of student attendance, assignments, grades, and behavior history. Mr. Pham provided a handout that listed step-by-step instructions for using StudentConnection. If any parents have questions about student identification numbers or passwords they should ask their children or go to the school site. Next year the district will have a similar program called PowerSchool Parent Portal.

## **DELAC Homework and Announcements**

Chairperson Valentina Hernandez reminded DELAC representatives to share with their ELAC what they learned about the reclassification process and to help raise the awareness that the ultimate goal of the English Learner program is reclassification to Fluent English Proficient. ELAC Liaison Yazmin Bozin-Mendoza shared a flyer about an informative community forum on Immigration Reform in City Heights on February 22.
