Emerging Business Enterprise (EBE) Awards for Capital Bonds Projects

To date, EBE construction bid awards for 2014 are \$37,696,962 or 51.49% of total construction awards. Please refer to the Business Outreach Report, Construction, 2014, 3rd Quarter table for further detail.
