



□ Fees are based on an annual retainer fee of \$78,000

- Fiscal Advising
- □ FRA's fees are paid from two sources
 - General Fund comprises 1/3 of the fees
 - Proposition S comprises 2/3 of the fees





Upcoming Items for SDUSD

- Preparing for new Proposition S issuance
 - Currently scheduled to issue a new series of bonds in May
- Tax and Revenue Anticipation Notes
 - Issuance of FY 2012-13 TRANs
 - Currently scheduled for issuance in July
- □ Potential 2012 General Bond election
 - Possible election to be held in November 2012 for new bond authorization
