Future of automotive repair coming to Madison High

State and local education officials gathered Thursday to officially kick off construction of Madison High School's newest facility, as part of the San Diego Unified School District's Proposition S projects.

In about eight months, students will be able to get a new high-tech and modern education in the car repair industry as a new Automotive Technology Facility is being built.

"This new facility will give students a real opportunity to learn automotive repair with state-of-the-art high-tech equipment," said San Diego Unified District Board of Education Member John Lee Evans.

This \$3.31 million project will have all the latest and greatest equipment in automotive repair, including eight indoor bays, five above ground lifts and two wheel-alignment racks.

The new facility will also have two classrooms, which will each hold 30 students, and a 60-seat stadium-style seating lecture hall that will also be used for student presentations, guest speakers, training space and special events.

Soltek Pacific Construction is in charge of this project and Zagrodnik and Thomas Architects, LLP was the firm that designed the facility.

The new 10,500-square foot facility will be replacing the current one, which is housed in a building constructed in 1962, with three outdoor bays and a small classroom.

The facility is being replaced to give students a new, more advanced way to learn a trade that Evans said will always be needed, especially in the United States.

"This on-the-job training is priceless because it will create jobs that cannot be outsourced," he said, adding that people will not drive out of the county let alone out of the state they live in to get their automobile fixed.

It is anticipated that students will be able to get under the hood and into this new facility by the time the next school year starts in August 2010.

This project is funded by a \$2.36 million Career Technical Education Grant, Proposition 1D, and through Proposition S, a \$2.1 billion school bond measure passed by voters in November 2008 intended to help repair, renovate and build new facilities at each of San Diego Unified's 181 schools.

Currently there is approximately \$43.55 million in projects going on at Madison High due to Proposition S.

Some of these projects at the 46-year-old school include repairs to the roof and building walls; renovations to the gym and locker rooms; and a new building for the arts, media and entertainment program.

San Diego Unified bond: a new woe

SAN DIEGO — The Union-Tribune editorial board has repeatedly stated its displeasure with the San Diego Unified School District board's handling of Proposition S, the \$2.1 billion bond measure approved by voters in November 2008.

In January, soon after taking office, the board's new majority swiftly moved to adopt rules that generally require union labor be used on construction and renovation work paid for by the proposition. Members Richard Barrera, John Lee Evans and Shelia Jackson purposefully froze out the bond oversight committee in making this commitment, to the committee's dismay.

They also kept district officials out of the decision-making loop, including then-Superintendent Terry Grier. It could hardly be more obvious that this was a payoff to the labor unions whose campaign donations helped them win election.

Now there is a fresh new reason to worry about what the district will do with Proposition S funds. Nigro, Nigro & White, the local company hired to do an independent performance audit of the bond's handling, is facing sharp criticism from the California League of Bond Oversight Committees.

In a formal complaint to the nonprofit, nonpartisan California Board of Accountancy, the bond oversight league said Nigro, Nigro & White was one of six firms in the state whose performance audits had failed to meet the state constitutional standard of measuring a school district's success in "meeting the full intent of the bond ballot language" and a district's "ability to maximize resources and efficiencies" in bond spending.

We are in no position to judge the accuracy of the bond oversight league's criticism. But if ever there was a school district that was likely to want a superficial audit of a specific bond measure, it is San Diego Unified and Proposition S. Be wary, San Diegans. And worried.

And hopeful that the California Board of Accountancy takes a hard look at the practices of Nigro, Nigro & White.

Newly built destroyer to arrive home today

SAN DIEGO: A new Navy guided-missile destroyer, the Wayne E. Meyer, is scheduled to arrive at its new San Diego Naval Base home this afternoon.

The ship is expected to arrive at its pier about 2 p.m. after a voyage from Philadelphia, where it was commissioned Oct. 10. It is the 58th Arleigh Burke-class destroyer to be built at the Bath Iron Works in Maine, all named for major figures in Navy history.

The Wayne E. Meyer is named for the retired rear admiral who led the development of advanced Aegis combat systems for the Navy's current classes of cruisers and destroyers. Meyer retired in 1985 and died Sept. 1 in Washington, D.C., at age 83.

The Meyer joins the new destroyer Dewey, which arrived in San Diego just before Thanksgiving.

LA MESA: Cyclists are being asked to join a holiday toy ride tomorrow by the La Mesa Bicycle Racing Club.


Cyclists carrying donated toys will ride from a La Mesa coffee shop to the East County Boys & Girls Club in El Cajon, where the gifts will be dropped off.

Agreement officially in effect for Prop S on advertised projects over \$1M

When heavy whispers of a labor agreement for San Diego Unified School Districtis Proposition S projects started at the beginning of this year, many did not know what effect it would have on the \$2.1 billion bond measure.

Now, after months of debating between local construction organizations and district officials -- and after the district's board of education voted 3-2 to install the labor agreement -- it has gone into effect on all projects estimated over \$1 million.

The labor agreement details the contractorsí requirements to work on any Proposition S project that is over the said amount. Prop S is a measure to repair all of the district's schools that was passed by voters in November 2008.

Any contractor that wants to work on any of the projects has to agree that they will not strike.

As of last Tuesday, any project that is advertised for bid and carries a price tag of over \$1 million will adhere to the district's Project Stabilization Agreement.

The first projects going up for bid will be at Clairemont, Madison and Point Loma high schools.

Each carries a package totaling between more than \$1 million to about \$5 million and all entail repairing and renovating technology-based buildings and equipment.

In 2010, schools such as Hoover, Morse and Scripps Ranch will have packages for contractors to bid on that will fall under the Project Stabilization Agreement.

In addition, the district has on their books a contract scheduled to be advertised for a school in the proposed downtown library that will be awarded June 22, 2010.

So far, the district has 56 project packages planned for bid that will fall under the Project Stabilization Agreement that are slated to be advertised and awarded from now until 2013.

The Project Stabilization Agreement has come under fire from nonunion contractors who say it favors union contractors because it forces them to pay into union health care plans and other dues.

Union contractors say the labor agreement is good thing because it ensures contractors are paid prevailing wages and health care benefits.

There are seven projects that are estimated to be lower than \$1 million and thus will not carry any of the stipulations of the Project Stabilization Agreement.

Unions face claims of unfair labor practices



School bond projects hiring policy at issue

A national anti-union organization has filed federal unfair labor practice allegations against local unions over a controversial policy dictating hiring terms for most work under the San Diego school district's \$2.1 billion Proposition S bond measure.

The National Right to Work Legal Defense Foundation said the "Project Stabilization Agreement" is discriminatory and "enriches union officials, punishes nonunion workers and employers, and sticks taxpayers with the bill."

Approved last May, the controversial labor agreement is set to take affect on all Proposition S projects that exceed \$1 million that are advertised as of Oct. 27. Under the agreement, contractors working for the San Diego Unified School District must hire local union workers and provide them with health insurance and other benefits. Contractors also will be required to give union apprentices first dibs at apprenticeship jobs.

The unfair labor charges were filed on behalf of Wesley Fuller, an employee of San Diego's Brady Co. Fuller installs drywall and has completed all state apprenticeship requirements, according to the Virginia-based nonprofit representing him. Because Fuller's apprenticeship program was not established through a union, his attorneys say he is being denied Proposition S work.

Among the unions that were accused of the unfair labor charges are the Southwest Regional Council of

Carpenters and San Diego Building & Construction Trades Council, AFL-CIO.

Another discrimination claim comes against school bond measure

Another discrimination claim was recently filed in connection with the San Diego Unified School District's Proposition S Project Stabilization Agreement.

The National Right to Work Legal Defense Foundation filed federal unfair labor practice charges on behalf of Wesley Fuller, a contractor from **Brady Co.**, against four labor union organizations for establishing a "discriminatory union only construction scheme" with the School District.

The labor unions include the San Diego Building and Construction Trades Council AFL-CIO, the Southwest Regional Council of Carpenters, the Painters and Allied Trades District Council No. 36 and the Plasterers Union Local 200.

The claim, which was filed to the National Labor Relations Board, stated that "unions are coercing, threatening and restraining the Brady Company and similarly situated contractors that perform or would perform construction work in the San Diego area with the objective of forcing or requiring that Brady Company and these similarly situated employers to enter into agreements with the unions that are prohibited by the National Labor Relations Act."

The claim also stated that "unions are causing and are attempting to cause employers that perform construction work in the San Diego area, including but not limited to the Brady Company, to not employ or provide work to employees who participate in or receive training through, nonunion apprenticeship programs on certain school construction projects in San Diego."

According to Stefan Gleason, vice president of the National Right to Work Foundation, the unions are able to do this based on the Project Stabilization Agreement that was put in place.

Proposition S is a \$2.1 billion school bond measure, which was passed by San Diego voters in November 2008 to repair and rebuild all of the district's schools.

The Project Stabilization Agreement (PSA) was approved by the school district in May and was amended in July to add another union organization, the Southwest Regional Council of Carpenters.

The labor agreement is like a collective bargaining agreement, Gleason said, that states contractors will not strike or have a work stoppage provided that contractors enter into a union apprenticeship program if a contractor is not formally in a union.

"This PSA is a blank discrimination," said Fuller, a journeyman with Brady for the past 10 years. "If I want to work on the Proposition S projects, I will have to join a union and go through the whole apprenticeship program and journeyman program again."

Gleason added that California law requires all qualified contractors employee's complete state-mandated apprenticeship programs, but that "it is illegal under federal law to discriminate against workers or businesses on account of union association."

The PSA will go into effect Oct. 27 with the first project to be advertised that day, and the first project under the PSA will be awarded January 2010. This is not the first discrimination claim against the school district for the use of its project stabilization agreement.

Back on July 30 of this year, the Associated General Contractors filed a lawsuit at the federal level claiming discrimination as well. The case has been continued on the court's own motion to Dec. 4.

Calls were made to all four union organizations were not returned by press time Tuesday.

The School District's legal board said they knew of the situation, but Mark Bresee, legal spokesperson, was not available to comment.

The regional director at the National Labor Relations Board regional in San Diego will investigate the charges and determine whether to prosecute the unions before an administrative law judge or dismiss the case.

Although each case is different, typically the Relations Board will take a few weeks to review and make a decision.

Either way, each party can appeal the ruling of the Board to all the way to the Federal Courts of Appeal.

Delays in construction projects ahead at San Diego Unified School District

Design and construction jobs will be delayed at the San Diego Unified School District, as board members have decided to push back the start times of some Proposition S projects.

With property taxes not coming in as once thought and the school district unable to change the tax rate for the sale of the school bonds, which would be used to pay for the construction work, \$96 million in school modernization projects will be delayed.

The tax rate is \$66.70 per every \$100,000 of assessed property.

"Because of the recession, property taxes are not coming in to pay off bonds, so delays in the sale of bonds have occurred," said John de Beck, San Diego Unified board member. "Therefore, we can't sell these school bonds as fast as we thought."

Due to the shortfall in property tax revenues, design and architectural work will be delayed three years; awarding of construction contracts will be pushed back four years; and the site discretionary funds program will be lengthened from five to 10 years.

Originally, these 40 modernization projects would have been executed in five years.

Proposition S was passed in November 2008 by San Diego voters with a 68.71 percent approval.

This \$2.1 billion school bond measure calls for repairs and renovations for all of the district's schools and also new equipment for staff and students.

But not everything pertaining to Proposition S work is coming to a halt.

The board decided to still go ahead with the I-21 program, which calls for new classrooms, a new data center to support new technology like wireless capabilities and the purchase of new laptops for students.

So far, the First Career Technology Education Project at Mission Bay High School has been completed, and three synthetic turf fields at Mira Mesa, Morse and San Diego High Schools have been completed under the Proposition S school bond measure.

Currently there is about \$10.5 million in ongoing construction projects including a 20-classroom building at Hoover High School; a student store at Mission Bay High School; multimedia center at San Diego High School; a culinary institute at Garfield High School; and an automotive program at Madison High School.

Over the next four months, roughly \$26 million will be contracted out including nine projects at Clairemont, Hoover, Morse, Muirlands, Madison and San Diego High Schools.

To date, of the \$2.1 billion from the school bond measure, about \$101.9 million has been obligated to construction and design services.

According to a district staff report, the district is about \$16.2 million under budget for Proposition S projects for this calendar year. The district budgeted \$85.7 million for 2009.

Proposition S has been met with some public outcry since a labor agreement, which the district calls a Project Stabilization Agreement or PSA, was put in place a couple of months ago.

It calls for certain restriction on who can and can't bid on these project, with one stipulation being contractors have to work and/or live within the district's boundaries, and in exchange there would be no work stoppages.

The PSA will go into effect Oct. 27 with the first project to be advertised that day, and the first project under the PSA will be awarded January 2010.

Since the PSA is a complicated issue, the district has conducted workshops for contractors and stakeholders' meetings for construction associations.

The district is also creating a position to oversee the labor agreement; and a start-up assistance contract is being negotiated with Parsons Constructors Inc.

Change in Superintendents

By the time you read this, Terry Grier will have left his post as the San Diego Unified School District superintendent and reported for his new superintendent position with the Houston school district. However, in mid-August, when it was first announced that Dr. Grier may leave San Diego, a coalition of community, business, education, and parent leaders thought it was worth urging the school board to try to retain Dr. Grier in light of the positive accomplishments that took place over the last school year, notwithstanding the enormous budgetary issues.

To that effect, an open letter addressed to the school board was placed in *The San Diego Union-Tribune* in late August asking the board to try and find a way to keep Dr. Grier in San Diego. The Scripps Ranch Schools Committee supported this idea and was one of the groups that

signed the letter. Ultimately, Dr. Grier accepted the Houston offer and the school board appointed Bill Kowba, a member of the district's senior management team for more than four years, as the interim superintendent.

As of press time, there was no timeframe from the board regarding efforts to find a new superintendent. We hope the board includes community input during the selection process.

New Technology Abounds

The school district has an initiative called i21, which is funded through Prop S and designed to equip classrooms, upgrade technology, and create 21st century learning environments. This school year all 3rd, 6th, and 9th grade classrooms will be equipped with interactive white boards, document cameras, and a netbook cart with enough netbook computers for every student in the class.

Each year the same equipment will be installed in additional grade level class-rooms and by 2013 all classrooms should be equipped. As Greg Collamer, EBS principal stated, the power of this technology is that it will raise the level of student engagement and make students a bigger part of the learning process in the 21st century.

Marshall Bus Program Update

After a couple weeks of school the Marshall Middle School Parent-Paid Bus Program is working relatively smoothly. There is always a little bit of adjustment at the beginning of each year, with one-

third of the students new to the program and new bus drivers. However, I believe this year was the smoothest start of all three years the program has operated.

A huge thank you from the community should go to Sharon Greener and Jennifer Madsen, the co-chairs of the committee, for the inordinate amount of time they spend making sure this program runs smoothly. 

School Repairs Wait While Schoobrary Jumps Ahead

The long, zig-zagging ramp down to the bleachers is too narrow for more than one chair. It leads down can't cross. Even after the school district tried to make the stadium more accessible, it's still hard for vis opposite side of the field.

And because there are too few seats for all Clairemont students during pep rallies or other school-wide often spill onto the ramp, making it unusable for teens with wheelchairs. Federal observers found that t year, even after an initial batch of repairs.

San Diego Unified promised to fix those problems with the money it got from Proposition S, a new cor last year. It even set a timeline, pledging to finish the fixes by December 2010.

But now San Diego Unified is likely to break that pledge. It plans to finish repairs in 2015. The school

Though it is only one of several projects scheduled to happen this year and next, parents have focused t it wasn't originally planned. Some question whether it is really needed.

Many of the delayed projects have been identified as pressing needs, but Clairemont has another wrink formal complaint with the civil rights office of the U.S. Department of Education about the school's prolodged, former Superintendent Terry Grier agreed to make the fixes by next December.

Delaying School Makeovers, Speeding Up the Schoobrary

As San Diego Unified gets less and less money than expected for school construction in the coming year delay, which to keep on schedule, and which to speed up.

It could delay the makeover of two aging City Heights schools. It could push back technology for the y modernizing campuses across the school district.

Yet it is planning to speed up the creation of the schoobrary, an unusual plan that will cost the district \{ forward in the schedule from 2014 to 2010. And the district is also considering speeding up technology whiteboards and voice amplifiers.

Revenues are falling because a tax levied on homes under Proposition S, a \$2.1 billion facilities bond tl yielding less money than expected as property values drop. While the school district will ultimately get than expected, pushing some projects back.

One example is the makeover of Crawford High School and Mann Middle School in City Heights, two either partially or wholly rebuilt. All of those plans could now be delayed. Yet San Diego Unified is also weighing whether to pick up th schoobrary.

Proposition S Update: All 2009 Contracts Awarded



The Board of Education recently awarded the last Prop. S
contract for 2009, bringing the total to 17 projects begun since the bond measure passed in November 2008. The projects represent a nearly \$65 million investment in the district's students, teachers and communities. During the first year of implementing Prop. "MM," the district only awarded \$7 million in construction contracts.

Designated as Prop. S "Fast Start" projects, the first-year construction contracts included the following <u>Career Technical Education</u> projects: Garfield HS Culinary Arts Program, Madison HS Automotive Technology, Morse HS Auto Body Program, San Diego HS Multimedia Arts Program, Mission Bay HS Entrepreneurship Program, San Diego HS Finance and Business, San Diego HS Hospitality, Tourism and Recreation; and Morse Culinary Arts Program. Other projects include construction of permanent classroom buildings to replace portables, Americans with Disabilities Act improvements for high school stadiums, technology upgrades and heating/ventilation/air-conditioning renovations.

One of the most significant projects is the start of the five-year <u>i-21 Interactive Classroom Initiative</u>, which was \$25 million of the \$65 million in Prop. S funding used for 2009. The technology-based initiative delivers a suite of new digital tools that are designed to create an engaging and personalized learning environment in the classroom. Main components include an interactive whiteboard, audio/visual cabinet, teacher presentation station, wireless voice amplification system, advanced model document camera and DVD player. Quick Bond Filing Earns National Praise



The Bond Buyer, a daily finance newspaper, has honored San Diego Unified with its regional Deal of the Year award for the district's quick work in earning \$38 million in school construction bonds tied in with the federal stimulus program. The sale of the bonds under the American Recovery and Reinvestment Act was the first in the nation. Because of additional tax benefits for investors under the Act, the favorable conditions allowed the district to sell \$170 million in bonds, \$20 million more than anticipated. The next bond offering is expected to raise \$20 million more as well.

The \$20 million will not change the \$66.70/\$100,000 tax levy approved by voters under the Proposition S authorization. As a regional finalist, the district is now being considered for the magazine's national Deal of the Year. Read the news-story.

Subject: Construction to Begin on Proposition S Projects—San Diego High School Culinary Arts Program, Business Management Facilities and New Classroom Building

On November 4, 2008, nearly 69 percent of the voters in San Diego passed the general obligation bond measure, Proposition S, so that San Diego Unified School District (SDUSD) could repair. renovate and revitalize 181 schools including San Diego High School.

SDUSD has begun construction on the Proposition S projects at San Diego High School. The following information describes the projects and outlines the construction activities.

Project: Using Proposition S funds and matching funds from a College, Career & Technical Education grant, the district will remodel and build new career technical learning environments for students in the Culinary Arts Program and the School of Business Management. Using Proposition S funds and state matching funds, a new 16-classroom, two-story classroom building will replace all of the old portable classrooms currently located at the site.

What to expect: Our contractors will do their best to limit noise, dust, and disruptions associated with these projects. Much of the work will have little impact on the surrounding neighborhood because the work areas are primarily located in the middle of the large campus and/or inside buildings. Students will be separated from areas of work and construction workers by screened fences and plywood barriers.

Completion: The business and the culinary arts facilities projects are expected to be completed in summer 2010. The two-story classroom building is scheduled to be completed in spring 2011.

We apologize in advance for any inconveniences that these construction projects may cause. When they are finished, San Diego High School will have program facilities that will benefit the students and the community for years to come.
