Payday is August 31, 2020

August Monthly Payroll Deadline

The deadline to enter absences and positive pay hours (including summer school) for the August 31, 2020 payroll is **August 17** at 5:00 pm. Positive pay hours that do not make this deadline will be paid on September 10. Absences that do not make this deadline will be reflected on the next salaried paycheck issued to the employee.

REMEMBER: Posting of time after the deadline can create a delayed paycheck for the employee and manual intervention by payroll. Only hours already worked may be reported and paid on any given payroll. Please do not report positive hours for time that has not been worked yet.

September Hourly Payroll Deadline

The deadline to enter positive pay hours for the September 10 payday is September 1 at 5:00 pm.

PeopleSoft Back-To-School Conference

School Site staff are encouraged to attend the **PeopleSoft - Back to School Conference** | **Virtual Back to School Conference**. The conference will be held via Zoom: Register in ERO to join in. Meeting invitation link and password will be sent via employees sandi.net email address after they are enrolled. The meeting will be open during the scheduled time.

Session A (HCM) - 9:00 -11:30 am. The last 30 minutes of each session is designated for moderated Q/A. This virtual conference will provide you with information about new and updated PeopleSoft processes, policies, and procedures related to Time & Labor and HR.

Session B (FIN) - 1:00 -3:30 pm. The last 30 minutes of each session is designated for a moderated Q/A. This virtual conference will provide you with information about new and updated PeopleSoft processes, policies, and procedures related to expenses, budgets, and eProcurement.

This is one of the most useful tools we have to help you understand your role in the payroll process. For new timekeepers, the conference will introduce you to the timekeeping module and give you valuable information on how to report and track time for your employees Expected Presentations: SAMS, Time & Labor, eProcurement, Travel/Expenses, and Finance.

REMEMBER TO REPORT ALL VACATION HOURS THROUGH AUGUST 31!

Vacation Accrual and Maximum Accumulation of 328 Hours

AASD members will not be forced to take vacation by August 15, 2020 in order to bring current vacation balances below 328 hours. (Per MOU between SDUSD and AASD Certificated and Classified bargaining units dated July 13, 2020)

Non-Represented and Confidential employees also will not be forced to take vacation by August 15, 2020 in order to bring current vacation balances below 328 hours (Per Board action dated July 28, 2020)

AASD Certificated employees who earn vacation accruals, AASD Classified employees, Non-Represented and Confidential employees must create an annual plan with their supervisor to bring their vacation balance below the 328 cap by August 15, 2023.

No agreements have been reached with any other bargaining unit at this time. Any vacation time that exceeds 328 hours at the end of August with the exception of the above mentioned units will be paid to the employee on the September pay warrant.

This report should be run on a monthly basis and provided to managers/supervisors who will use the information to manage leave schedules and advise their employees.

Verify SAMS Jobs

Please remember to verify on the SAMS system that substitutes (certificated and classified) assigned to your location actually showed up and worked the assigned jobs. Substitutes will not be paid unless the jobs they worked have been verified in SAMS. You must verify jobs in SAMS for those that have worked the assignment no later than the day before the timekeeper cut-off for each payroll period. It is recommended that you take a few moments each day to verify the previous day's jobs. Partial Month Pay for Classified Employees

Classified ten (10) - month and eleven (11) - month traditional employees who do not work the whole month of August will be paid for working a partial month depending on their work schedule/calendar. They will be paid with the time reporting code of **PMP** (Partial Month Pay). This code will automatically appear in Time and Labor and you will see it on the timesheet.

Please do not change or delete PMP!

Deleting or changing this code will affect how the employee is paid. If you need to report an absence or report positive pay hours on the same day as PMP, please do so by adding a new row on the timesheet. If you have questions regarding the reported PMP hours, please contact your payroll specialist.



Employees No Longer at Your Site

If on August 31 you receive a pay stub or paycheck and the employee is no longer at your site, please call your payroll specialist before mailing the check to the employee. The payroll specialist will verify if the check is valid, and if so, will instruct you to mail the check to the employee. If it is not valid, you will be asked to send the paycheck or pay stub back to Payroll. It is very important to call Payroll immediately with this information.

<u>Reports</u>

Please review the *Time and Labor Manual for Timekeepers (www.sandiegounified.org > Staff Portal > Departments > Payroll >Timekeepers: Payroll Resources > PeopleSoft Time and Labor Manual v9.2.5)* for information about the reports you are required to run and those reports which will help you reconcile your payroll in order to correct errors before the payroll is confirmed. The Audit Paid to Reported Time Report, the Site Account Code Charge Monitor Report and the Cross-Site Account Code Charges Report must be reviewed and signed by the site administrator each month. These are official audit documents.

Visiting Teachers

Visiting teachers are credentialed unit members employed to work in the absence of a regular contract unit member. They cannot be used for extra help, testing, or any type of pull-out support. A visiting teacher who has retired from the district can perform non-classroom duties.

A visiting teacher assigned to replace a part-time teacher or a full-time teacher who is absent for only part of the day may be required to render and shall be compensated for a full day's service.

Certificated substitutes are paid the long term rate starting on the 6th day of a teaching assignment. On the 6th day, change the reason code to the long term reason in SAMS/Smartfind Express. If you do not change it on the sixth day, you will need to go into Time and Labor to update the time reporting code and you will need to contact the substitute help desk and have them change the reason to "Long Term".

ELPAC testing can only be done by a regular teacher or a retired teacher. The visiting teacher can be used as a substitute in the classroom while the teacher completes the ELPAC training. Each retired teacher working as a CELDT tester will need to be entered into SAMS/Smartfind Express and have a job number prior to the assignment. In the event you contact the retired teacher directly to work in an ELPAC assignment, you must ensure the job is entered into SAMS/Smartfind Express. Hours should not be entered manually into the visiting teacher job record in PeopleSoft Time and Labor. Retired teachers who are conducting ELPAC training will be paid at the non-classroom teacher rate.

Classified Permanence Bonus

The OTBS and OSS bonus paid on August 5, 2020. This bonus is for all salaried, classified employees in the OTBS and OSS bargaining units in an active monthly assignment who reached permanent status as of June 1, 2020. Paraeducators and all other employees not in the OTBS and OSS bargaining units do not receive a bonus.



August Resignations and Leaves of Absence

Please notify your payroll specialist as soon as possible if you have an employee that is resigning or going on a leave of absence effective this month. <u>Please do a termination or leave of absence PAR.</u>

Please run the Filled Positions Report for your locations (*Workforce Administration > Workforce Reports > Filled Positions*). If there is an employee you know is not at your site, please call or email your payroll specialist. If an employee does not appear on the list and should appear, please call or email your payroll specialist.

We need your help in monitoring this as it will ensure our employees are paid correctly!

Payroll Reconciliation/Audit Reports Chart

Please make sure reporting tools are being used to both reconcile payroll transactions prior to the payroll deadline for each payroll, and then for auditing those transactions after the payroll closes. There are official audit documents that must be produced, reviewed and signed by administrators/managers for each of the two payrolls produced each month. There is a new tool called the Payroll Reconciliation/Auditing Reports Chart. This chart provides an overview of each of these reporting tools that must be run each month. It highlights what needs to be signed and what needs to be retained and a brief "How to" column that gives you some pointers on using that tool.
