the PSAT/NMSQT for the 2020-21 Academic Year

## **Brief Explanation:**

San Diego Unified School District will sponsor the PSAT/NMSQT for all 11<sup>th</sup> graders. All district 11<sup>th</sup> grade students are encouraged to take the PSAT/NMSQT on January 26, 2021. Considering this exam is only available in-person, safety precautions will be thoroughly explored prior to hosting students.

College Board's PSAT/NMSQT offers all students early preparation for college with a practice exam, online resources for future test score improvement and scholarship opportunities. College Board's PSAT/NMSQT exam serves several purposes and providing it during the school day to our students allows for the most equitable opportunity for all to achieve their college goals.

The district will provide funding for the PSAT/NMSQT for students in grade 11 only. The district will not cover the cost for these exams for students in other grades. The goal in focusing on 11<sup>th</sup> graders is (1) to ensure ample safe space and proctors to host this in-person exam and (2) the National Merit Scholarship Qualifying Test is only available to juniors. Sites may elect to have students in other grades take the exam, though sites will be responsible for collection of payment from students and payment of these exams to College Board.

### **PSAT/NMSQT** Content:

The PSAT/NMSQT exam is 139 questions in three sections: Reading, Math, and Writing and Language. It measures what students have learned in high school so far and what students can improve on for success in college. ## **Implementation:**

- All district 11<sup>th</sup> grade students are encouraged to take the PSAT/NMSQT on **Tuesday January 26, 2020**.
- District will host a testing coordinator workshop on November 20, 2020 to review ordering and safety requirements to administer in-person exams. If it is not safe to host in-person exams, a contingency plan will be shared at this time.

## **Important PSAT/NMSQT deadlines:**

- November 6, 2020 = PSAT Coordinators must confirm they have enough fee waivers to cover all 11<sup>th</sup> graders who qualify. - December 4, 2020 = ordering deadline for January exam date
- December 7, 2020 = deadline to request testing accommodations for January exam date
- January 26, 2021 = PSAT/NMSQT exam date at school sites (no online option)
- January 29, 2021 = Coordinators will identify all students who qualify for fee waiver and send invoice to <a href="mailto:ramato@sandi.net">ramato@sandi.net</a> for district to pay for 11<sup>th</sup> graders who do not qualify for fee waiver.
- Mid-March 2021 = PSAT/NMSQT score reports released online (<a href="https://studentscores.collegeboard.org/home">https://studentscores.collegeboard.org/home</a>)

# Payment – ONLY required if testing students other than 11th grade.

PSAT/NMSQT exams cost \$17.00 each. Each site must cover the cost of PSAT/NMSQT tests for its students in grade 9 or 10. School sites will make payments for any 9<sup>th</sup> or 10<sup>th</sup> graders who take the PSAT/NMSQT exam as they pay any other vendor.
