# San Diego Unified School District Athletic Probationary Contract

Per SDUSD policies and procedures, students with a 2.0 grade point average (GPA) and citizenship point average (CPA) or higher are granted athletic eligibility to participate in sports and extracurricular activities. Students who hold under a 2.0 GPA/CPA are able to appeal for one athletic probationary contract to be allowed to play for one grading period per school year on this athletic probationary contract.

#### II. TERMS

Under the terms of this contract, the student shall:

- 1. Complete homework on a regular basis
- 2. Attend school and be on time to class on a regular basis
- 3. Be a role model in the classroom as it pertains to behavior
- 4. Seek assistance from teachers if struggling on tests and quizzes
- 5. Seek assistance from teachers if struggling to understand classwork or homework
- 6. Alert Parent/Guardian and School Designee listed above if struggling with any of terms 1-5

#### **III. AGREEMENTS**

As the student, I choose to go on academic athletic probation and understand that this will be the only grading period this school year that I can utilize this option.

I agree to the terms of this contract as stated above and understand that breaking the terms of this contract may result in my athletic eligibility being immediately revoked. I also acknowledge my responsibility and understand that failure to comply with the terms of this agreement will result in my not being able to play in interscholastic athletic contests.

As the Parent/Guardian, I agree to view and monitor my student's attendance and grades weekly on PowerSchool, or any other posted site the teacher is using, and report any concerns to the School Designee. I agree to provide a place and expectation for my student to do homework each night that is distraction free. I agree to work with the teacher to make sure my student is attending any after school tutoring necessary to pass the class. I agree to the terms of the contract and permit my student to go on academic athletic probation. I also agree to notify the School Designee if the student has not upheld the terms of the contract. I understand the athletic probationary period is only for one grading period and that the breaking of the terms of this contract will result in student's current athletic eligibility being revoked.
