- A referral for a comprehensive health assessment including a chemical substance screening may be made as required for a third offense.

**PARTICIPATION IN INTERSCHOLASTIC OR EXTRACURRICULAR ACTIVITIES**

This only applies to the <i>1st Offense</i>.
