Emerging Business Enterprise (EBE) Awards for Proposition S Projects

EBE construction bid awards for 2012 to date are \$36,589,040 or 38.44% of total construction awards. Please refer to the Business Outreach Program, Proposition S, 2012, 3rd Quarter: January 2012 – September 2012 table for further detail. Cumulative EBE awards since commencement of Proposition S projects through September 2012 are currently at 39.95% for construction.

Cumulative EBE professional services awards since commencement of Proposition S through September 2012 are \$31,753,242 or 34.6% of total professional services awards.
