Action Requested: Implement Required Comprehensive Sexual Health Education Grades 6-12.

Brief Explanation:

Required Comprehensive Sexual Health Education for Grades 6-12 is outlined below. Completion of the instruction fulfills CA Education Code requirements for comprehensive sexual health education. Principals will identify teachers of existing courses to attend professional development and implement the required curriculum during the school year. The Sexual Health Education Program will collaborate with high schools to teach the 1-hour lessons in grades 9, 11, and 12.

Rights, Respect, Responsibility is implemented in Grade 6 by designated teachers, in Grade 8 by science teachers, and in Biology classes (inclusive of students in Grades 9-12) or in another content-area class taught to all Grade 10 students.

*Instruction includes classroom lessons in site-designated content areas. Kaiser Permanente's Educational Theater Program [What Goes Around](#) can be implemented in lieu of the Grade 11 *STI and HIV Prevention* lesson.

Professional development is required by CA Ed Code [§ 51934\(a\)](#) prior to implementing the new *Rights, Respect, Responsibility* curriculum.
