A. PURPOSE AND SCOPE

1. To assist school personnel in supplying initial information regarding child development centers.
2. To provide a current list of child development centers in operation in the district.

B. LEGAL AND POLICY BASIS

1. **Reference:** Board policy: F-1000, F-3975; Education Code Sections 8200 *et seq.*

C. GENERAL

1. **Originating Office.** Suggestions or questions concerning this procedure should be directed to the Early Childhood Education Program, Child Development Programs Office, Instructional Support Services, Institute for Learning.
2. **Definition: Child Development Centers:** Locations with child development programs under the direction of the State Department of Education and administered by the local school board to provide care, supervision, and instruction for children of low-income parents who are employed, in school or training, or are disabled, as well as children referred for child protection.
3. **Application.** Parents may call the Early Childhood Education Program at (858) 496-8126, or apply at the center in which they wish to enroll their children.
4. **Criteria for Eligibility.** Information on eligibility is available at all centers or at the Early Childhood Education Program located at the Instructional Media Center (IMC) Trailer L, at (858) 496-8126.
5. **Payment of Fees.** Certified checks or money orders may be accepted in lieu of cash for payment of fees; personal checks are not accepted.
